## British Columbia's Provincial Health Officer Continues to Endanger the Lives of All British Columbians and Must Be Replaced Immediately!

You, your entire government and all the people, flora and fauna in British Columbia have been - and are still being - betrayed by British Columbia's Public Health Officer, Dr. Perry Kendall, MD, MPH, who has consistently told governments and the public that wireless radio products, such as Wi-Fi routers, cell phones, Smart Meters, cordless phones, baby monitors, cell phone towers, etc. are safe – when that is absolute untrue!

Even though Dr. Kendall has been B.C.'s PHO for 16 years, he remains astonishingly ignorant of the fact that modern militaries of the world have for decades incorporated into their vast arrays of lethal weapons of war the very radio frequencies that he and his ignorant, naïve and/or corrupt colleagues in Health Canada (and elsewhere) now permit wireless and telecom companies (joined recently by electric utilities) to use in the wireless radio products now in use across Canada and the world!

Dr. Perry Kendall has not once responded to – or even acknowledged receipt of – any of my many attempts to enlighten him over the years that the militaries of the world long ago proved that the <u>low-level</u>, <u>pulsed</u>, <u>non-thermal radiation</u> emitted by all of today's wireless devices is harmful to all living things: humans, flora and fauna. History would tell him - if only he cared/dared to look:

- The Soviets/Russians irradiated the U.S. Embassy in Moscow for 23 years, from 1953-1976, for just 6-8 hours a day, 5 days a week. In doing so, they used the same frequencies as are found in today's wireless products, with similar modulations but far weaker power density (signal strength) than today's radio devices emit. Yet two consecutive ambassadors died of cancer, a third died of Leukemia-like symptoms; at least 16 women developed breast cancer and many other staff came down with various maladies!
- Militaries have long considered microwave radiation to be the perfect weapon, for one cannot see it, hear it, smell it or taste it, and it leaves no trace of evidence behind.
- The Soviet/Russian and U.S. Militaries separately have conducted thousands of secret scientific studies since the 1940s of every frequency within the radio frequency (RF) spectrum (3 kHz-300 GHz) to determine which specific frequencies are most harmful to humans.

- Militaries have long known that frequencies within the 1-5 GHz range are the most lethal to humans because they penetrate more deeply all organ systems of the body thus putting all organ systems at risk. Frequencies in this range are particularly effective against the human brain, central nervous system and the immune system. (This is precisely where virtually all of today's wireless radio products operate – including baby monitors and Smart Meters!)
- Militaries have also long known that PULSED radiation is more harmful to humans and all living things than is the 'continuous wave' radiation emitted by a microwave oven! (Again, all of today's wireless devices emit "pulsed" radiation!)
- By 1971 the U.S. military had compiled some 2,300 studies on the biological responses to radio and microwave frequency radiation, which paid particular attention to the harmful effects of non-ionizing radiation on humans.
- In 1971 U.S. President Richard Nixon's own EMR (electromagnetic radiation)
   Advisory Council warned that: "Power (radiation) levels in and around American
   cities, airports ... and homes may already be biologically significant." The population
   at risk "may well be the entire population." The consequences of undervaluing or
   misjudging the biological effects of long-term, low-level exposure could become a
   critical problem for the public health, especially if genetic effects are involved. (This
   was at least 15 years BEFORE today's wireless devices appeared!)
- In 1975 the U.S. Defense Intelligence Agency warned its own personnel of the dangers of low-level radiation, including microwave sickness (flu-like symptoms, depression, suicidal tendencies) to cancers and leukemia.
- The Soviet/Russian scientists produced many thousands of studies dating back to the 1940s which showed the harmful effects of non-thermal radiation. These were offered to the Western agencies (WHO and ICNIRP) but were declined, and are not included in the libraries of either Western agency. Nor do Western agencies, including Health Canada, consider them in their own deliberations to establish 'safe' Exposure Limits - which are based on their own "industry-funded" studies.
- Scientists know there is a direct correlation between the exponential growth in wireless products and a corresponding increase in diseases such as cancers, Alzheimer's, Autism, Parkinson's and other neurological, central nervous system, and immune system disorders.
- In 1979 the U.S. NIOSH and OSHA (National Institute of Occupational Safety & Health and the Occupational Safety & Health Agency) recognized the harmful effects of non-thermal radiation; both urged the government to impose the Precautionary Principle – but were ignored!
- In 1986 the U.S. EPA (Environmental Protection Agency) recommended that pulsed, non-thermal RF/microwave frequency radiation be classified a "Possible" carcinogen – but were ignored!
- In 1990 the U.S. EPA recommended that ELF EMFs (power line, 60Hz, electric and magnetic fields) be classified a "Probable" carcinogen but were ignored!

- In 1995 the U.S. EPA wanted to establish strict radiation guidelines to protect the
  public, but a U.S. Senate Committee stripped EPA of its authority, slashed its
  budget, directed EPA not to conduct any more research into radiation, and
  transferred that responsibility to FCC (Federal Communications Commission) which
  had/still has no scientists, just political appointees!
- In 1999 the U.S. Consumer Affairs Commission said: "Current thermal guidelines associated with EMR (electro-magnetic radiation) are irrelevant. Cancer and Alzheimer's are associated with non-thermal EMR effects." They too were ignored!
- In 2014 Globally, 56 world-class scientists condemned Safety Code 6 and called on Health Canada to intervene to prevent an emerging health crisis!
- In 2014 22 Canadian scientists condemned Safety Code 6 and called on Health Canada to protect Canadians from radio / microwave radiation exposure!
- For decades, the international scientific community has been urging all governments
  of the world to reduce the radiation Exposure Limits drastically and to impose the
  "Precautionary Principle." In the most recent example, the BioInitiative 2012 Report,
  its recommendation, if observed, would require Canada to reduce Safety Code 6
  limits by a mind-boggling 3-6 MILLION times!

Shamefully, not only has Dr. Perry Kendall assiduously avoided me, he has done the same to other informed organizations that have attempted to enlighten him, such as Citizens for Safe Technology, Stop Smart Meters BC, Canadians for Safe Technology and many individuals. Disgracefully, he is determined to listen only to Health Canada.

Had Dr. Perry Kendall done his job competently and diligently on becoming B.C.'s PHO some 16 years ago, not one of today's wireless radio devices that fall under provincial jurisdiction would have been allowed into the province of British Columbia! Had he the moral fibre and any semblance of a backbone, he would have enlightened the provincial government of the dangers of cell phones and cell towers, and urged them to table their firm opposition to the egregiously high radiation Exposure Limits reflected in the globally pilloried Safety Code 6! He most certainly would have enlightened government – all governments within B.C. – that none of the major re-insurance companies of the world (Lloyd's of London, Swiss Re. etc.) will ensure against any health-related claims attributed to non-thermal radiation! He would also have been aware and kept himself abreast of the thousands of independent studies conducted by world-class scientists from all corners of the globe that consistently show that any man-made wireless frequency ("radiation") harms all living things!

In my view, Dr. Kendall's conduct over these past 16 years has been unconscionably reprehensible and despicably cruel! To me he is a heartless criminal! Whatever happened to the Hippocratic Oath? Whatever happened to the sane, sensible, world-admired and respected, democratic Canada in which I grew up? Whatever happened to things like honesty, ethics, caring, common decency, respecting a person's home and their privacy? Whatever happened to our Charter of Rights and Freedoms?

While one cannot re-write history nor undo the grievous harm already inflicted upon countless thousands if not millions of unsuspecting and helpless people, surely democratic governments will now move quickly to begin protecting their citizens. Crippling law suits are coming; that's a certainly, given the incontrovertible evidence that has long been available! As a minimum, until the Federal Government of Canada puts an end to the systemic corruption in Health Canada, British Columbia must impose its own relatively 'safe' radiation Exposure Limits, which I suggest should match the recommendation of the earlier <u>BioInitiative 2007 Report</u>. This alone would require Safety Code 6 to be lowered by 10,000 times! And, finally, wireless Smart Meters must be completely banned – immediately! Those already installed across the province should immediately be replaced with harmless yet adequate analogue meters.

And finally, given all that has been said above, Dr. Perry Kendall, MD, MPH should be summarily fired, publicly stripped of his OBE and thrown in jail! Lastly, he should be stripped of his medical license to practice medicine anywhere in Canada! ## Jerry Flynn's BIO

I spent 22 of my 26+ years in Canada's military (1952-1978) in the arcane fields of Electronic Warfare and Signals Intelligence, which included two years as the Executive Officer and Operations at one of Canada's largest and most sensitive intelligence-gathering radio stations. Here I personally directed some 200-plus specially-trained radio operators and technicians. Next I was posted for two years to National Defense Headquarters, Ottawa, into the Directorate of Electronic Warfare. In DEW I was the only staff officer charged with supporting Canada's only army EW unit. In this position I worked closely with U.S. and NATO army EW units, attended a lengthy NATO army EW officers' course in Anzio, Italy, and participated in a large NATO army EW field exercise in the Black Forest of Germany. Previously, I had spent years aboard two Canadian Warships conducting Radio Warfare exercises with other Canadian, U.S. and Australian warships. Throughout my career I often worked closely with the U.S. National Security Agency (NSA) and, to a lesser extent, with Britain's GCHQ. My qualifications and experience in two environments (navy and army) are still unique in Canada's forces.
